Bear Valley Electric Service, Inc. ("BVES") hereby transmits for filing the following:

SUBJECT: *2026 Base Revenue Requirement Balancing Account Amortization*

PURPOSE

The purpose of this Advice Letter is to request authority from the California Public Utilities Commission ("Commission") to amortize the under-collection balance in the 2025-2026 Base Revenue Requirement Balancing Account ("BRRBA"), Pre-June 30, 2025 BRRBA residual balance, Vegetation Management Balancing Accounts ("VBMA"), and refund over-collection of 2025 Pension Balancing Account and Wildfire and Natural Disaster Resiliency Rebuild Program Balancing Account ("WNDRRP").

BVES is seeking to amortize the net under-collection balance of \$2,154,233.05 over a 12-month period through a base rate adjustment.

BACKGROUND

The disposition of the balance in the BRRBA at the close of each year, plus any transfers or adjustments to be made to the BRRBA, will be addressed by BVES in a Tier 2 Advice Letter filing, if the amount of the under- or over-collection is equal to or greater than 5% of the revenue requirement established for the previous 12 months.¹

On July 24, 2025, BVES filed Advice Letter No. ("AL") 522-E. In AL 522-E, BVES requested authority from the Commission to 1.) amortize the residual balances in the BRRBA for the year 2025; 2.) amortize the under-collection balance in the 2025 BRRBA; and 3.) refund the over-collection in the BVES Pension Balancing Account and various memorandum accounts.

BVES requested to amortize the net under-collection balance of \$2,181,509.47 over a 12-month period. The Commission approved AL 522-E on August 28, 2025. The amortization from AL 522-E expires on August 31, 2026.

GOLDEN STATE WATER COMPANY GENERAL OFFICE ALLOCATION

In D.25-01-036, the Commission authorized Golden State Water Company ("GSWC") to allocate to BVES: 1.) expenses incurred in the operation of the General Office ("G.O.") Allocation Expenses; and 2.) Common Plant costs.

BVES is authorized to adjust its revenue requirement when there is a change to BVES' allocation of GSWC's (i) General Office cost, (ii) common plant cost, or (iii) employee pension and benefit costs, each as approved by the Commission in GSWC water operations. GSWC's GRC decision was effective January 1, 2025; therefore, BVES adjusted its BRRBA for Year 2026 to reflect GSWC's current G.O. allocation to BVES adopted in D.25-01-036.

Section 10.1 in the Settlement Agreement adopted in BVES D.25-01-007, states:

10.1 Confirmation of Authority to Adjust Base Rate Revenue Requirements Due to Allocation of General Office Costs. The Settling Parties confirm and agree that BVES was

previously authorized in D.14-11-002 to adjust the base rate revenue requirements through the Base Revenue Requirement Balancing Account advice letter process whenever the Commission authorizes a different revenue allocation to BVES for Golden State Water Company general office costs, common plant allocations, or pension and benefit costs.

RATE IMPACT

The rates change for low-income customers under the California Alternate Rates for Energy ("CARE") Program and for Non-CARE customers are as follows:

Adjustment to Base

Non-CARE customers:	\$0.01618/kWh
CARE customers:	\$0.01285/kWh

Upon approval of this advice letter, the proposed rates will replace the current rates that were approved in BVES's AL 522-E on the effective date of this advice letter.
