BEAR VALLEY ELECTRIC SERVICE INC. REQUEST TO INCREASE RATES IN ITS 2023 GENERAL RATE CASE  
APPLICATION NO. 22-08-010**

Bear Valley Electric Service Inc. (Bear Valley) and the California Public Utilities Commission (CPUC) would like to hear from you. You are invited to participate in a public forum, also called a Public Participation Hearing (PPH), about Bear Valley 2023 General Rate Case (GRC) Application No. 22-08-010.

This public forum is part of the proceeding that will be documented and placed into the formal record so the CPUC can make a decision about Bear Valley’s request. You can make comments and raise concerns to the CPUC Administrative Law Judge overseeing this application. Your participation by providing your thoughts on Bear Valley’s request can help the CPUC make an informed decision.

**Information About the Application**

On August 30, 2022, Bear Valley Electric Service, Inc. (Bear Valley) filed an application with the CPUC requesting to increase revenues for its 2023-2026 GRC. Bear Valley requests a revenue requirement of \$50.28 million for 2023, an increase of approximately \$10.54 million (26.51%) from 2022 adopted revenues. Bear Valley is also requesting increases in revenues of \$2.24 million (4.45%) in 2024, \$1.85 million (3.53%) in 2025, and \$2.93 million (5.39%) in 2026. The application is requesting a total combined increase of \$17.56 million (39.88%) over the four-year cycle 2023-2026.

If the CPUC approves this application, Bear Valley will recover forecasted costs in electric rates over a four-year period. The average residential monthly bill using 325 kWh per month would increase by approximately \$28.19 or 30.35% per month in 2023.<sup>1</sup>

**How does the rest of this process work?**

This application has been assigned to a CPUC Administrative Law Judge who will consider proposals and evidence presented during the formal hearing process. The Administrative Law Judge will issue a proposed decision that may adopt Bear Valley's application, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

Parties to the proceeding will review Bear Valley's application, including the Public Advocates Office. The Public Advocates Office is an independent consumer advocate within the CPUC that represents customers to obtain the lowest possible rate for service consistent with reliable and safe service levels.
